


OVERVIEW

User Experience

Mobile Videostitial is an Ad format that expands to the full size of the screen on mobile devices and tablets browsers. This Ad contains video that is resized to maximum available width and height by maintain video aspect ratio and doesn't stretch video.

The background contains a light box like semitransparent background that cover to browser width and height. On the top of Ad there is logo on left, Clickthrough button in center and close button on right. Top button always resize depends on the video container width.







Open source template notes:

The open source ad template is built to the correct Sizmek specifications and can be easily re-skinned. This example is designed to function as described in this kit.

All amendments are up to the individual skill of the creative developer.

Ads built outside Sizmek specs can cause delays and additional costs to the creative agency.


